CONDITIONS OF PARTICIPATION

1. Participation in the Forum is prescribed by Steering Committee Chairman written offer of invitation only.
2. If you do not have Steering Committee invitation, you may file an application for participation. Your application will be submitted for Steering Committee consideration. You will be informed in writing about Steering Committee decision.
3. Steering Committee reserves the right to reject the participation invitation for a person or an organization, submitted the application, without assigning any reasons.
4. All participants are required to confirm their decision to take part in the Forum in writing, by filling in the registration form on the site.
5. Participation agreement is being concluded with all Forum participants, which acknowledges obligations of the participants and organizers. If you are invited to take part in the Forum on the free basis by Steering Committee decision, the contract zero-sum is specified in the participation agreement concluded.
6. Upon receiving your request, we will reach you to answer your questions and elaborate the organizational details. Contracts, invoices and other essential documents will be sent you by fax and by post after Steering Committee decision notification.
7. All participants will be provided especially prepared for the Forum handouts package, which will serve as reference source during the Forum. You will keep it after the event for your work.
8. At the latest of 15 May 2007 you may cancel your participation, addressing the letter in renunciation, and obtain the repayment for the registration fee you paid in. Organizers withhold participant registration administration costs in the amount of 50% from participation cost. The divestment, received later than the deadline indicated, does not foresee the reimbursement.
9. Participant substitution may be performed till 20 May 2007. Please, do inform us in writing about these changes. Paid-in registration fee may be taken into account as the new participant application payment, however the Steering Committee approval procedure remains the same (refer to the item 2).
